Developed in response to community feedback seeking clearer understanding of the PAB's role

Uses video storytelling to educate, inform, and engage beyond written reports

Increases transparency, corrects misinformation, and clarifies the PAB's mandate

Centers lived experience, community voice, and real-world accountability

Aligns with national best practices in civilian oversight

## Why It Matters & What's Next

Shows oversight in practice and not just on paper

Helps build trust through honest, accessible communication

Explains current legal and operational realities, including Locust II

Amplifies multiple perspectives: community members, experts, and oversight leaders

Will expand to include education on investigations, policy work, Locust Club dynamics and *Know Your Rights*

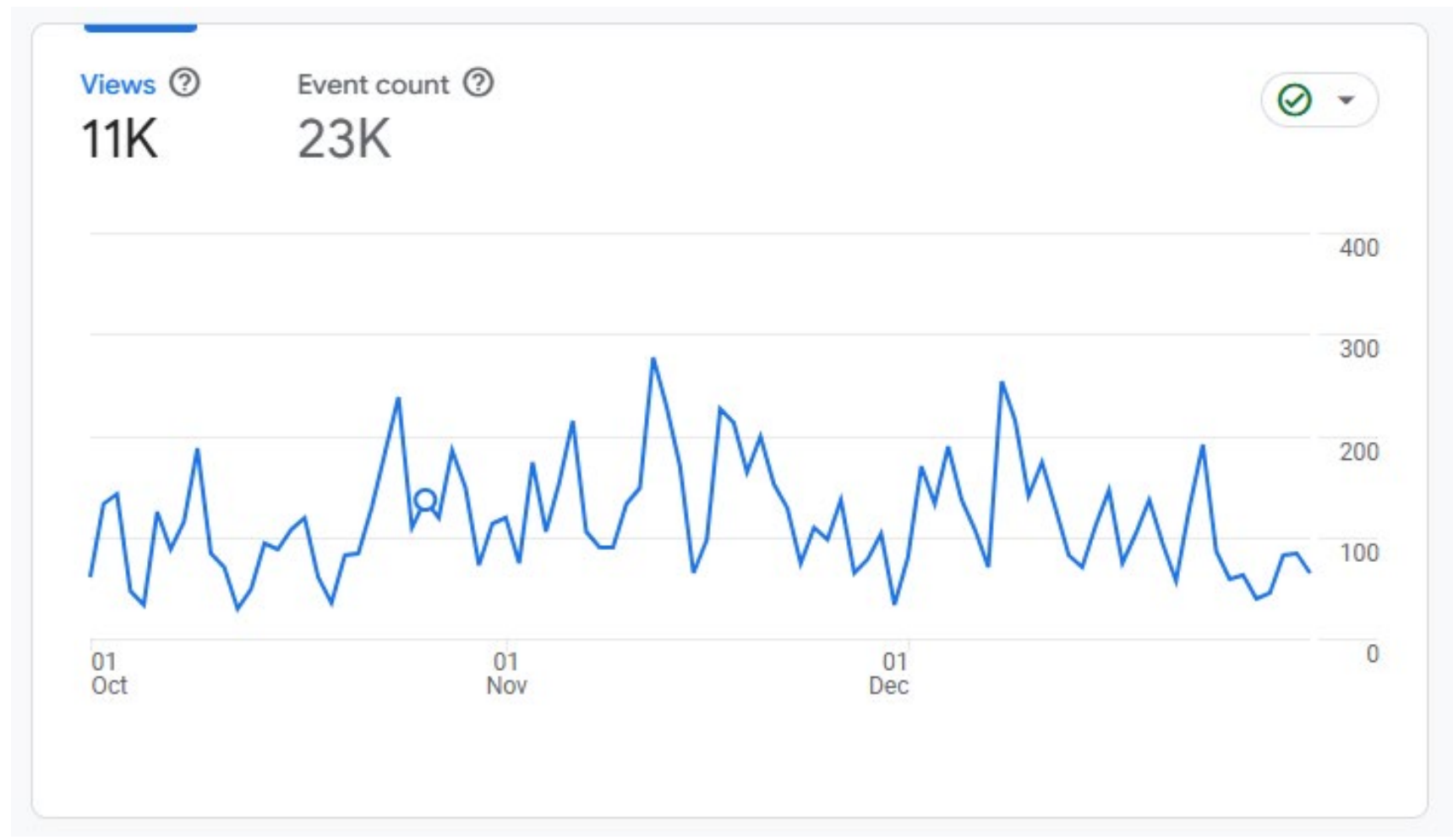
# Website Traffic – December 2025







# Website Traffic – Quarter 2



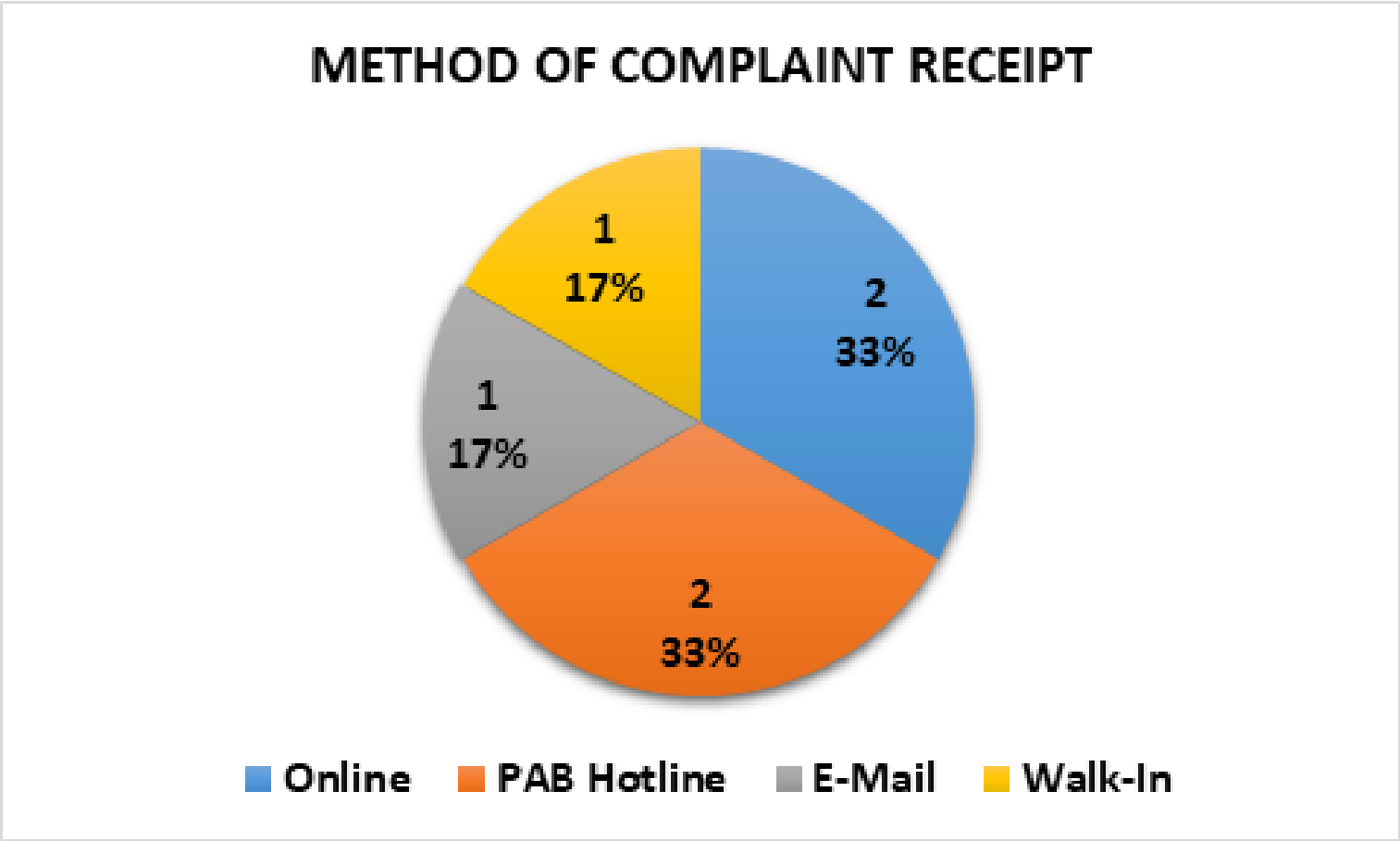


# Accountability And Transparency

In December 2025, the Police Accountability Board received six (6) complaints through multiple channels, including the online portal, email, walk-ins, and the PAB hotline.



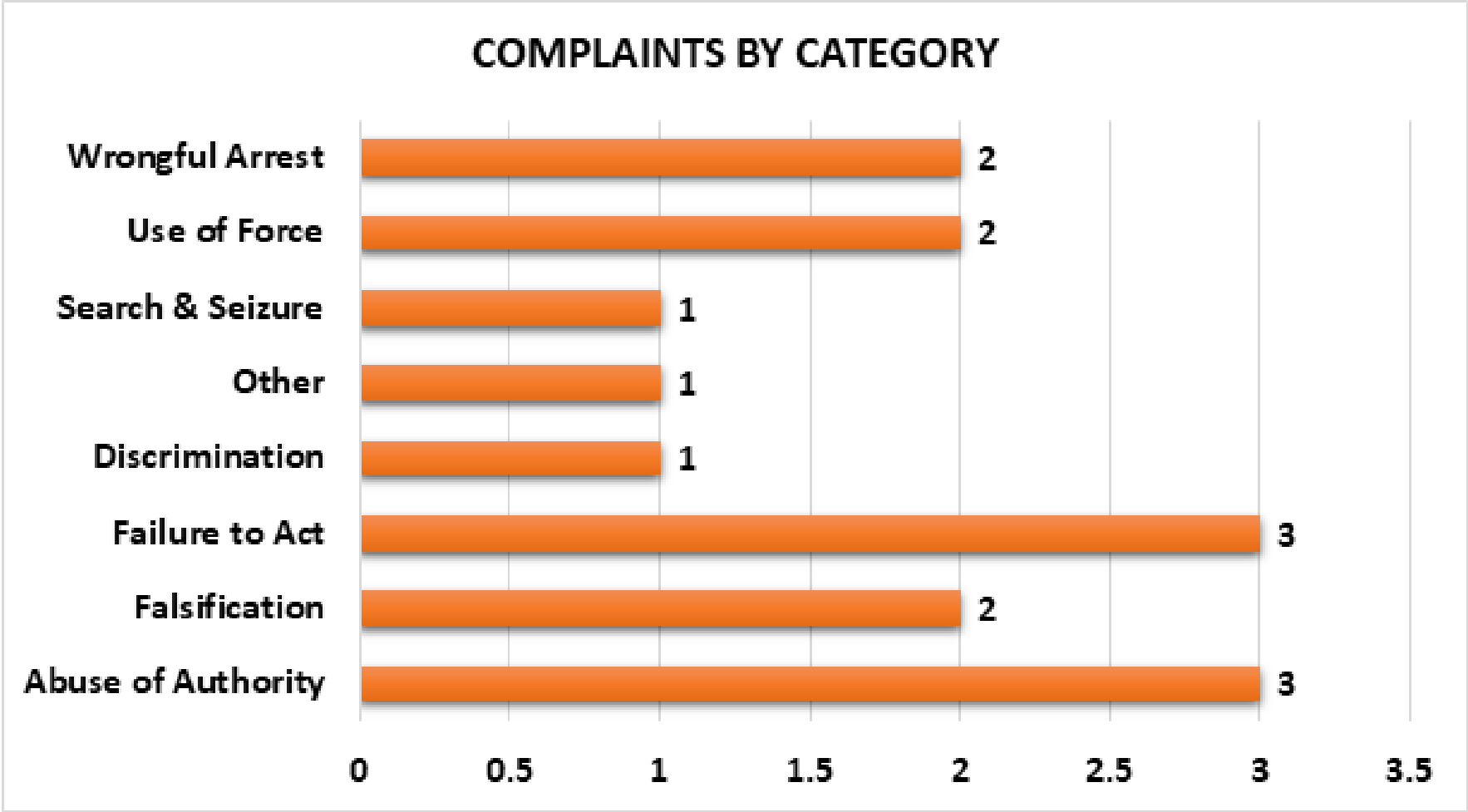


# Accountability And Transparency

## Complaint Categories

Each complaint is categorized based on the type of alleged misconduct. In December, the categories reported most frequently were:

Abuse of Authority (3)  
Failure to Act (3)



Note: A single complaint may fall into more than one category. For example, a complainant may allege both Discrimination and Use of Force in the same case. As a result, the number of complaint categories (15) exceeds the total number of complaints received (6). Definitions for all complaint categories are provided at the conclusion of this report.

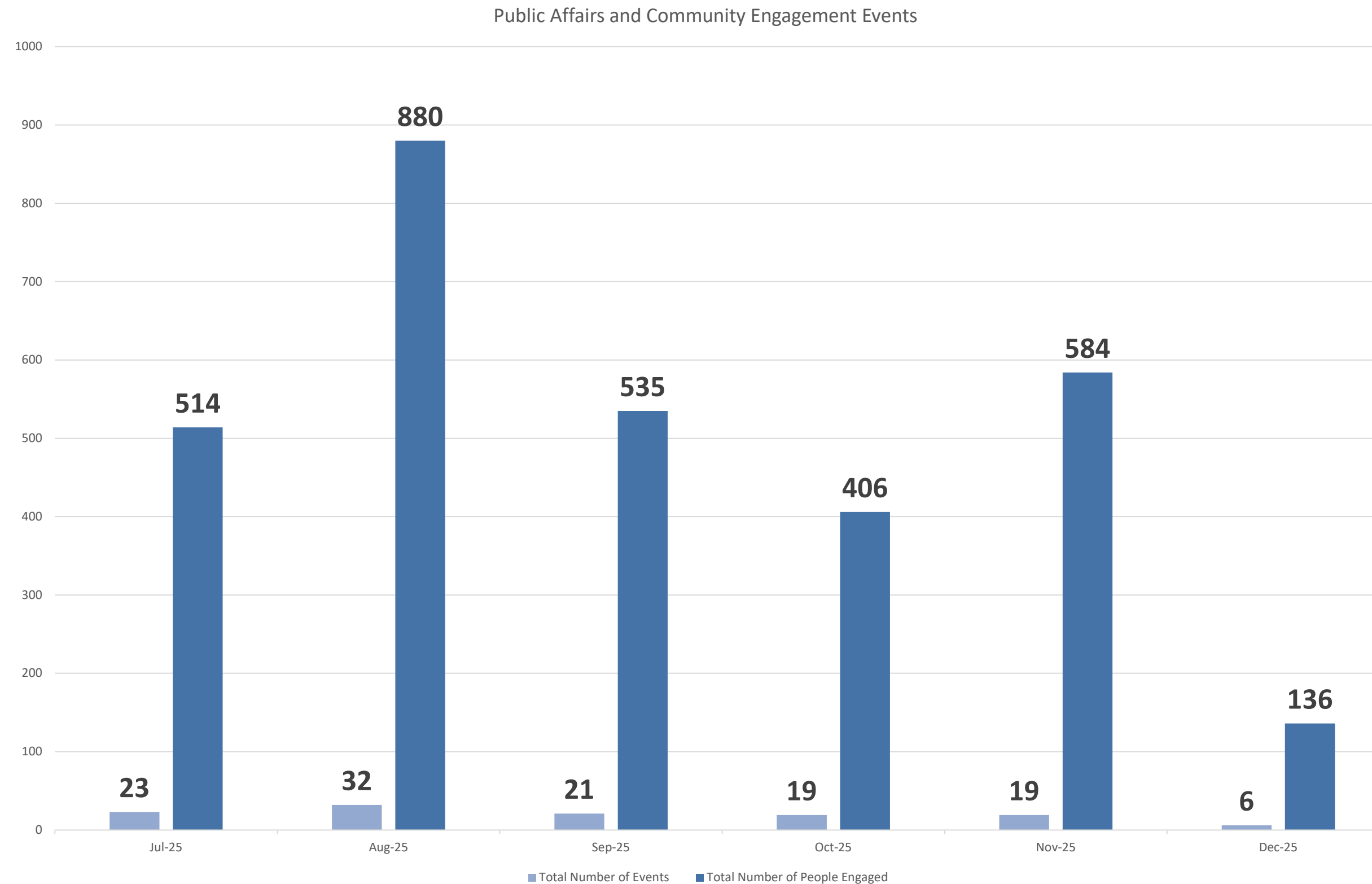

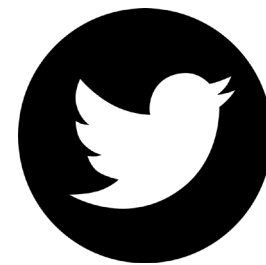
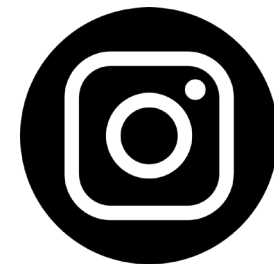
