

# Police Accountability Board June 2025 Meeting Report Prepared By: Dr. Lesli Myers-Small, Executive Director, Police Accountability Board

# Overview

This report outlines the major activities, updates, and developments of the Police Accountability Board (PAB) since the May 2025 Board meeting. Over the past month, the PAB has engaged in a productive City Council budget hearing, deepened public outreach, supported staff development, and advanced strategic planning initiatives. These efforts underscore the agency's commitment to its Charter responsibilities and to adapting in light of the constraints imposed by the Locust Club II ruling.

# **1. Community Engagement & Public Affairs**

## City Council Budget Hearing

On May 30, the PAB participated in the FY 2025–2026 City Council Budget Hearing. Engagement with Councilmembers was thoughtful and productive, with several insightful questions raised. We are especially grateful to Board Chair Larry Knox and Board Vice Chair Drorah Setel for attending and supporting the presentation.

- Providing Council with monthly website utilization reports
- Submitting visual documentation illustrating the evolution of Civilian Police Accountability
- Sharing the Board-approved Policy and Oversight Agenda
- Scheduling a work session with Council to review the finalized Strategic Plan

## 5. Communications & Technology

#### Website Review and Usage

Following City Council's request for enhanced digital transparency, the PAB continues to assess and enhance its website as a primary public engagement tool.

#### Key Actions Underway:

- Monthly website utilization reports are now shared with City Council
- A comprehensive review of navigation, content visibility, and accessibility is in progress
- Planned upgrades include mobile optimization, ADA compliance, and Spanish-language content expansion

### Website Utilization Highlights:

April 2025:

- Total Sessions: 1,064
- **Top Pages Visited:** "Board & Staff," "Investigative Reports," and "Submit a Complaint"
- **Traffic Drivers:** Significant spike due to bot activity on Good Friday (anomaly accounted for in data interpretation)
- User Engagement: Notable increase in new users navigating directly to the investigative content
- **Opportunity Area:** Analytics show growing interest in transparency—suggesting a need for clearer data visualizations and easier report access

### May 2025:

- Total Sessions: 964
- Top Pages Visited: Continued high traffic to "Board & Staff" and "Investigative Reports"

- Traffic Drivers: Social media engagement
- Engagement Patterns: Users spent longer durations on the "Who We Are" and "Investigative Reports" pages, signaling public interest in both governance and findings
- **Opportunity Area:** Leverage rising page views to introduce interactive elements such as video summaries and FAQ sections

Together, these reports reflect consistent public interest in the PAB's oversight function and a strong foundation for continued digital transparency.

# 7. National Oversight Leadership Engagement

On May 13, 2025 executive director Dr. Leslie Meyer Small and Director of Policy and Oversight De'Jon Hall served as panelists at the N.A.C.O.L.E. Regional meeting in New York City. Their participation elevated the visibility of the PAB's work and reinforced its leadership within the national civilian oversight community, Hojin Choi staff attorney also attended the event contributed contributing to the agency's broader learning and strategic alignment with evolving oversight trends.

# 8. Statewide Consortium Development

Also on May 13, 2025 during the N.A.C.O.L.E. Regional Conference Executive Director Dr. Lesli Myers- Small formally proposed the creation of a New York State Consortium of Civilian Oversight Agencies. This emerging group is designed to:

- Share resources and best practices
- Advocate for state-le legislative reform
- Provide mutual support and high-profile oversight matters
- Elevate the public awareness of oversight bodies' role in impact.

The proposal was met with enthusiasm by oversight leaders across the state. Plans are underway to convene an inaugural working session in summer 2025. The PAB will play a key role in shaping the direction of this important collaboration
