Case Management and Investigations:

Workflow Transition

Following the Locust Club II court's ruling, the division formerly known as the Investigations Division has transitioned to a documentation-forward model emphasizing evidence preservation and accountability. Key developments included:

- Implementation of a new Source of Information Request process
- Standardization of tools, including status update letters and evidence protocols

- The Deputy Executive Director/General Counsel position posting has closed. The team is currently awaiting applicant materials from the Department of Human Resources.
- A meeting with the Department of Human Resource Management is scheduled for June 11, 2025, to review the proposed job description and division structure for the Accountability and Transparency Department, reflecting the shift from the former Investigations Division.
- Ongoing improvements are being made to ensure the website is more accessible and user-friendly. Current efforts include:
 - ADA compliance
 - o Spanish language expansion
 - Exploration of additional language support based on commonly spoken languages in Rochester.
- Monthly website analytics show increased engagement, especially on the former Investigations and Governance pages
 - o Board members were provided with the April and May 2025 website utilization reports and an executive summary.
 - The growing engagement reflects community interest and reinforces the Board's commitment to meaningful public access and collaboration.

Collaboration and External Relations

- **Citizen Police Academy**: The Executive Director presented at the Citizens Police Academy on Wednesday, May 28, 2025.
- **Public Education**: Planning is underway for public education efforts to explain the Board's role and functions in the current post-ruling environment.
- NACOLE Regional Conference: On May 13, 2025, the Police Accountability Board presented at the NACOLE Regional Conference in New York City:
 - The Executive Director and Director of Policy and Oversight, presented on two separate panels.
 - Ho Chun Choi, Staff Attorney also attended.
 - Participation reinforced Rochester's visibility in national oversight discussions.

- NYS Oversight Consortium Proposal: At the NACOLE conference, the Executive Director proposed the creation a New York State Consortium for Civilian Oversight, which was well-received.
 - The consortium aims to share best practices, advocate for legislative reform, and support agencies during high-profile oversight cases.
 - o Credit was given to Chair Larry Knox for initiating this work over a year ago.

- Due to the Locust Club II court ruling, the following KPIs are currently impacted:
 - Complaints cannot be closed or completed with findings
 - The average investigation length will be skewed due to the halt in investigative authority

5. Chair Report (6:43 PM)

- Chair Knox reinforced the importance of continued public engagement and complaint intake. The community is strongly encouraged to continue submitting complaints via phone, email, or the website. While individual investigations are currently restricted due to ongoing legal proceedings, the PAB continues to monitor for patterns and systemic concerns. Chair Knox noted that if the PAB wins the current legal appeal, full investigative powers will be restored, allowing complaints to be investigated as they were prior to the ruling.
- Encouraged community members to apply for open Alliance and District Board seats.
- Acknowledged PAB's unique standing and power compared to other cities in New York and nationwide and emphasized the need to defend its structure and mission amid legal challenges.

- Director Brittany Wells introduced Hannah Ferguson, a senior Criminal Justice student from St. John Fisher College and current PAB intern through the City of Rochester Fellowship Program.
- Hannah expressed gratitude for the opportunity and shared her enthusiasm for the experience.
