Meeting Agenda and Minutes

1. Welcome & Introductions (6:04 PM)

• Chair Knox called the meeting to order and requested introductions. Board members and the Executive Director introduced themselves.

2. Approval of Prior Minutes (6:06 PM)

• **April 3 Minutes:** Motion was made by A. Brown to approve the minutes, seconded by L. Tecleab. Motion carried unanimously.

3. Staff Reports (6:06 PM)

The Executive Director delivered a report focused on the April 2025 Locust Club II court decision, which curtailed the PAB's investigative and disciplinary authority.

The decision invalidated the PAB's ability to:

- Investigate allegations of police misconduct
- Impose or recommend discipline
- Issue subpoenas
- Conduct disciplinary hearings

Internal Compliance Measures Implemented:

- **Website Audit**: All language referencing prohibited investigative authority was either removed or revised for legal accuracy.
- New Complaint Confirmation Letter: Implemented to clearly communicate to complainants the board's revised scope and limitations.
- Suspension of Investigative Activities: All panel reviews and hearings concerning officer conduct were immediately halted. Investigative activities such as interviews, evidence collection, and the use of case templates were discontinued.
- **Document & Report Revision:** Templates and publications are being revised to focus solely on the board's permitted policy review and oversight functions.
- **Internal Staff Training:** Conducted training for staff on distinguishing between allowed and prohibited activities post-ruling.
- **Public Communications Update**: FAQs, phone scripts, and all public-facing materials are being rewritten to reflect the board's limited scope.

Legal Consultation:

- The PAB is consulting with legal counsel to:
 - o Explore the feasibility of appealing the court ruling.
 - o Consider requesting a legal stay to delay the enforcement of restrictions.

Ongoing Duties of the PAB Under New Limitations:

Though no longer authorized to investigate, the PAB will:

- Accept complaints (without investigative follow-up).
- Monitor systemic patterns in RPD conduct.
- Review and evaluate policies and procedures.
- Issue oversight and policy-focused reports.
- Advocate legislatively for restoration of full oversight authority.

4. Chair Report (6:11 PM)

- Acknowledged board members and staff for resilience before and after the court's ruling.
- Noted that 75% of voters approved the creation of the PAB and described the Locust Club's legal challenge as a direct challenge to the will of Rochester's residents.
- Called for state-level appeals and coalition building with:
 - o City Council
 - o Mayor's Office
 - Community allies
- Reaffirmed the PAB's commitment to police oversight despite legal setbacks.
- Noted potential for appeal and further legal consultation in executive session following the public meeting.

Board Members Comments:

• Arlene Brown:

- o Thanked staff for rapid compliance measures.
- o Emphasized the need for community trust and understanding of board's goals.
- o Clarified the board is not anti-police; the goal is mutual reimagining of safety.
- o Reassured the community that their voice remains central.

• Yvonne Wilson:

- o Urged public to contact elected officials to advocate for the PAB's powers.
- o Reiterated the board's legitimacy through a democratic vote.

• William Clark:

- Criticized the old oversight system for its lack of transparency and secrecy around misconduct findings.
- Cited this as the primary reason citizens overwhelmingly voted to establish the PAB.
- o Promised to fight for the restoration of the PAB's powers.
