Overview

This report outlines the key activities, transitions, and accomplishments of the Police Accountability Board (PAB) since the last board meeting. With the successful conclusion of our community survey, staffing transitions, and increased collaboration with city partners, this period has been marked by growth, reflection, and renewed momentum toward transparency, trust, and accountability.

1. Community Engagement & Public Affairs

Community Survey Results Released

Between November 2024 and February 2025, the PAB received 212 survey responses from community members across 43 zip codes. Key findings include:

- 66% of respondents believe the city is not doing enough to hold RPD accountable.
- 75% support the release of investigative reports.
- 68% favor PAB having disciplinary authority.

The press release was distributed to key stakeholders and the media. Full survey analysis and action steps were developed and will be presented at the April 3, 2025, board meeting.

Community Engagement Highlights

- Presentation to the Youth Policy Task Force Group on March 12, 2025, and presentation at the Youth Policy Task Force Town Hall at School 33 on March 27, 2025.
- Continued development of the Youth & Community Engagement Subcommittee (up for vote this meeting).

- Interview with Upstate NY Gospel Magazine focused on transparency and faith-based partnerships.
- Planning participation in "Be the Healing" Symposium, a citywide event focused on justice and healing.

Social Media & Outreach

- The PACE team will begin recording monthly social media content featuring Board members to increase visibility.
- Board support is requested to participate in 1-2 hour monthly taping sessions.

- Cooper Townsend joined the Investigations Division on March 24.
- **Casey** completed Level 1: Forensic Video Analysis & the Law through LEVA, advancing our video evidence capabilities.

- SFT uploads, RPD packet prep, Genetec, and misconduct data entry process updates completed.

- Ongoing work on General Order 502 revision and community education.

- PAB continues exploring increased presence in Spanish-language and youth-centric platforms.


